## **Primary Care Medicine Shortage Processes**

#### Scope

This process document is designed to provide advice to NHSGGC Pharmacy Services Primary Care & Community Pharmacy staff on how the Primary Care Central Prescribing (Prescribing Support) and Community Pharmacy Development Teams assist in the management of medicine supply problems and shortages.

Please note, separate reporting mechanisms exist for vaccine shortages, please contact pharmacy public heath for further details ggc.pharmacypublichealth@nhs.scot.

#### **Advice on Management of Shortages within Primary Care**

NHSGGC Pharmacy Services Primary Care & Community Pharmacy staff who need advice on medicine supply problems and shortages should first refer to;

- Specialist Pharmacy Services (SPS) Medicine Supply <u>Tool</u>. This tool provides the latest
  information on supply issues, actions to take, alternatives to use, and expected resolution
  dates. Content is provided by Department of Health & Social Care (DHSC) and Medicines
  Value and Access (MVA) team, NHS England. Login is required.
- The NHSGGC Current Medicine Shortages <u>Page</u>. This page hosts all current Scottish Government Medicine Supply Alert Notices (MSANs) and local advice where available.

#### **Reporting of Shortages within Primary Care**

Where a shortage needs to be reported (published advice not available or insufficient), NHSGGC Pharmacy Services Primary Care & Community Pharmacy staff should report through the following communication channels;

- General practice and Health and Social Care Partnership (HSCP)staff ggc.prescribing2@nhs.scot
- Community pharmacy Shortages Reporter App <a href="https://members.cps.scot/shortages/">https://members.cps.scot/shortages/</a>.

### The Role of the Primary Care Central Prescribing (Prescribing Support) Team

- Review Scottish Government MSANs and where necessary provide onwards advice to HSCP Pharmacy Teams
- Publish MSANs and local clinical advice memos on the Current Medicine Shortages SharePoint page
- Where necessary, collaborate with key departments on management of specific medicine shortage and risk assessment of alternatives
- Where necessary, collaborate with key departments on the publication of local clinical advice memos
- Remove published advice from the Current Medicine Shortages SharePoint page when shortage has resolved
- Provide information to prescribers on key shortages via ScriptSwitch® electronic prescribing decision support

## The Role of the Community Pharmacy Development Team (CPDT)

- When a shortage is judged to have a significant impact, a communication will be circulated to all community pharmacies within NHSGGC advising of this shortage, along with any recommendations associated with continuity of care of patients that have been affected.
- If a community pharmacy advises CPDT of a potential shortage, the pharmacy will be encouraged to report this shortage on the CPS shortage web page.
