Community Pharmacy Palliative Care Resource Folder

By now all Community Pharmacies in GG&C will have received a copy of a purple folder entitled 'Palliative Care Resources for Community Pharmacy'. This resource has been developed to support pharmacy teams provide a baseline service to patients requiring palliative care. The folder also contains information on the Palliative Care Network established to provide a more specialist service and includes details of the 71 participating pharmacies, the list of additional medicines they stock and guidance on accessing the courier service for delivering urgently required palliative care prescriptions.

We have also included guidance on the prescribing of unlicensed medicines used in palliative care and some helpful advice on the prescribing of midazolam and other CD's. The new GG&C Palliative Care Guidelines are also contained in the folder for reference. These can also be accessed at www.palliativecareguidelines.scot.nhs.uk along with some patient information leaflets which you may find useful.

We have supplied a copy of the Macmillan resource catalogue and some Macmillan patient leaflets which can be ordered from their website. It may also be useful to find out about what support services are available locally and keep details of these in your folder. We would ask you to complete the contacts page on the inside front cover with details of your nearest network pharmacy, District Nurse base and out of hours District Nurse telephone numbers. Please familiarise yourself with this resource and keep it the pharmacy where it can be easily accessed by relief/locum pharmacists and support staff.

The folder represents a considerable amount of work and special thanks are due to the Macmillan Pharmacists Facilitator Project Team along with Janet Trundle and Elayne Harris for their invaluable input. Smoking Cessation Training: Friday 13th May, 2011

In order for a Community Pharmacy to become an accredited Smokefree Pharmacy it is mandatory for a one day training programme to be completed by pharmacists, locums and support staff.

We presently have some places available for the event on the 13^{th} May 2011at J B Russell House, Gartnavel Royal Hospital

The training will include key elements from the NES Smoking Cessation training pack, together with brief intervention techniques and NRT products. It is open to all pharmacists and support staff. Regular locums are particularly encouraged to attend, therefore please pass this message on where appropriate. Fees will be paid to the pharmacy contractor to cover the costs of staff attending, (as pre-reg students are paid through NES, no need to claim).

Instalment dispensing requests from GP practices using EMIS

A problem has been identified for those GP practices that use EMIS clinical system. The problem relates to the instalment dispensing instruction which under certain circumstances won't print on the prescription, however will be present in the electronic message.

Our guidance at the moment for pharmacies who receive instalments prescriptions from GPs using EMIS for dispensing weekly etc -

- a. If you already scan **all** scripts you should continue to do so. If the electronic message includes instalment instructions which **do not** appear on the paper you should return this to the GP and request a new prescription.
- b. If you **do not** routinely scan all scripts you should check the paper script for <I> printed to the left of the DM&D code. This indicates that there should be instalment instructions.

CMS and PCR clinical support events – asthma

The second event in a series of training sessions to support community pharmacists with CMS, particularly in relation to care planning, will be held on asthma.
